

# Dance Party LIVE!

(also referred to as DPL)

## REVIEWERS AGREEMENT/WAIVER

As a “Registered” *Dance Party LIVE!* Reviewer, you will be expected to provide honest and mature reviews of a variety of Dance Club conditions, many of which will be used by our viewers to determine if the club you reviewed is a club they would want to visit.

Approved *Dance Party LIVE!* reviews will be posted on our website:

- Upon submitting your application, to become a *Dance Party LIVE!* reviewer, we ask each reviewer to submit a headshot, a full-length photo, and short bio, that **WILL NOT be published** until they reach VIP Reviewer Status (and only published upon consent of the reviewer)
- After their 10<sup>th</sup> club review, our most prolific reviewers will achieve VIP Status.
- VIP Status means that we will (regularly) quote that specific reviewer’s reviews on our website and our shows, and encourage our viewing audiences to check out their reviews.
- We will ask the VIP reviewer if they would like their headshot and short bio, to be posted with their reviews.
- When a VIP reviewer gets to their 25<sup>th</sup> approved review, *Dance Party LIVE!* will offer that VIP reviewer an opportunity to be a guest on one of our DPL Shows (if they approve).
- When a VIP reviewer reaches their 50<sup>th</sup> approved review, *Dance Party LIVE!* will offer to include them as an “on-camera” Co-Host, featured in one of our shows.

Our goal is to review dance clubs ALL OVER THE WORLD. Our shows will follow the reviews, ALL AROUND THE WORLD, and when we arrive at the home turf of one of our VIP reviewers, we will invite them to guest appear on a show, at one of their favorably reviewed dance clubs.

**Our reviewers ARE NOT EMPLOYEES** of *Dance Party LIVE!* They are **INDEPENDENT content contributors**; however, they are expected to maintain a respectable code of ethics and avoid engaging in any illegal activities, and ***Dance Party LIVE!* IS NOT RESPONSIBLE** for any damages to, or caused by, any of our independent reviewers, before, during, or after the execution of their reviews.

We expect ALL reviewers to read and accept the terms of their “independent” relationship with Dance Party LIVE!, prior to submitting their first review. This agreement is intended to establish a “good faith” relationship between Dance Party LIVE! and all Independent

Reviewers, including simple instructions on how to upload any images, and the review form, to the *Dance Party LIVE!* website.

Reviewers are expected to submit the completed review questionnaire in a timely manner (preferably within 72 hours of their club visit)

While our *Dance Party LIVE!* Reviewers may gain a certain level of notoriety, they are **NOT ALLOWED to use the name: *Dance Party LIVE!* for any personal business gain WITHOUT EXPRESSED WRITTEN CONSENT from *Dance Party LIVE!***

I have read and agree to these terms and waive any rights to bring claims against Dance Party LIVE! or its affiliates, resulting from any circumstances their review may cause, whether intentional or unintentional.

If any disputes arise, out of the relationship between you (as a DPL reviewer) and us (Dance Party LIVE!) the dispute will be arbitrated in California, USA, and Dance Party LIVE! is NOT responsible for any costs or other financial damages/expenses resulting from any dispute.

I agree to the terms of this “Good Faith” agreement, and if a misunderstanding or disagreement should arise, I will make every effort to resolve the issue(s) with a simple written conversation with a member of the DPL management team, and I will make every effort to exercise my “Reviewer” status responsibly and maturely.
